State the grounds on which the internal appeal is based:

1. On 5 June 2017 SAHA made a request to the City of Johannesburg for information under PAIA ('the request'). A copy of the request is attached to this appeal.
2. On 6 July 2017 the City of Johannesburg wrote to SAHA, informing SAHA of the transfer, in full, of the request to the Gauteng Department of Human Settlements (the Requestee). A copy of the emailed communication is attached to this appeal.

3. On 10 July 2017 SAHA wrote to the Requestee noting that we had been notified of the transfer of PAIA request SAH-2017-JHB-0005.
4. On 15 July 2017 and 20 July 2017 SAHA wrote to the Requestee, requesting acknowledgement of receipt of the PAIA request.
5. On 14 August 2017 and 24 August 2017 SAHA wrote to the Requestee, reminding them that in accordance with PAIA they were required to respond to the request within 30 days and that period had expired.
6. On 8 September 2017 SAHA again wrote to the Requestee noting that they had failed to respond to the PAIA request within the 30 days provided for in PAIA despite SAHA writing to them to remind them of their obligations. SAHA provided the Requestee with an opportunity to contact it in order to resolve the matter, failing which SAHA would submit an internal appeal.
7. Despite SAHA reminding the Requestee of its obligations under PAIA, the Requestee has failed to respond to the request. The failure by the Requestee to provide a decision on the request constitutes a deemed refusal in accordance with section 27 of PAIA.
8. SAHA contests the refusal and submits this appeal.
9. Section 11 of PAIA provides that a requester must be given access to a record of a public body if the requester complies with the procedural requirements in PAIA and access to the record is not refused in terms of any ground for refusal contemplated in Chapter 4.
10. SAHA has complied with the procedural requirements of PAIA and the Requestee has not offered any ground for refusal in Chapter 4 for refusing access to the requested records. The Requestee has therefore unlawfully refused access to the requested records.
11. Furthermore, there is no justifiable basis on which the Requestee could refuse access to the requested records.
12. SAHA therefore respectfully submits that the relevant authority should order that SAHA be given access to the requested records pursuant to section 77(2) of PAIA, which empowers the relevant authority to substitute the information officer's decision with a new decision.
