

12 May 2004	Wednesday, at 6am residents of Merebank were gassed out by Engen yet again with Hydrogen Sulphide. Residents' complaints were logged at eThekwini Emergency Services and at the South Durban Community Environmental Alliance offices.
7 Jun 2004	Engen Refinery in South Durban had a fire on the plant on Monday at 12 pm
7 Oct 2004	Thursday, Engen Refinery gassed out communities for two hours. Immediately after this there was a loud bang, which could be heard for kilometers. A fire in sub station resulted in a power outage at the Engen Refinery at 9h25 this morning. This resulted in a fire and the plant had to be shutdown.
31 Dec 2004	ENGEN refinery spills oil into Badulla canal - claiming rain as the reason.

18 Jan 2005	At about 20:45 a fire occurred at the Engen Refinery in South Durban. The fire occurred at one of Engen's solvent tanks. The Explosion rocked houses in Merebank and Wentworth. The sirens sounded twice which meant there was something serious happening on the plant.
01 Feb 2005	At about 5pm a diesel tanker spilled on Duranta Road. Metro Fire and Police attended to the spillage. The road was covered with sand to cover the spillage.
11 Mar 2005	At about 10pm there was another diesel tanker spilled on Duranta Road. Metro Fire and Police attended to the spillage. The road was covered with sand to cover the spillage.
29 Mar 2005	A fire occurred at the Engen Refinery between 12 - 12.15 pm. It occurred on a valve of the lube oil plant. Fire fighters were sent out to put out the fire.
May 2005	During the period of 7 March 2005 to the 9 April 2005 an investigation undertaken by the SDCEA highlighted that the eThekwini Health Dept.'s monitoring station at Settlers School recorded 64 exceedences of the 10 minute WHO guideline related to Engen operations. This translates to Engen violating the permit condition during this period on 29 occasions.
Aug 2005	During July & August 2005 another investigation by the SDCEA highlighted another 10 exceedences of the 10 minute WHO guideline related to Engen operations. This translates to Engen violating the permit condition in total on 39 occasions.
Sept 2005	26/09/2005: At 21h30 a feed pump at the unsaturated gas plant (USGP) at Combo unit tripped causing a compressor to trip. This resulted in loss of feed to the Debutanizers which caused pressure safety valves (PSV) to lift .all gases were routed to the flare as per design. This resulted in a large flare. The pump could not be restarted because the switch gear had burnt out. Maintenance information shows that thorough thermograph check was done on the switch gear in June\July. The incident lasted 23 minutes
Nov 2005	21/11/2005: fire occurred at the Engen Refinery on Monday at 7.30am
April 2006	On Sunday the 16 April 2006 evening - Residents who live near the Engen Refinery in Wentworth and Merebank were shaken by a large bang. They reported what they thought were flames and smoke which didn't look normal after the enterior, which occurred about 9.10 pm. This accident left one worker injured. The injured worker was apparently burnt when asphalt fell on his arms while the fire was being extinguished. Engen spokesman Raymond Damon said the fire broke out in the vacuum unit which produces oil from crude in the early stages of the petroleum production process. The fire had apparently

	raged on for 20 minutes before being brought under control	
110CT 2006	Today residents from Wentworth, Merebank and Treasure Beach were greeted with a pall of black smoke coming out of the Engen Refinery which went on for over an hour. Residents clogged the Engen hotline to find out if they must evacuate, only to find that the refinery telephone is only operated on weekdays after 08.00am .The SDCEA office including my cell phone recorded over fifty telephone calls with some residents sending us Sass enquiring what is going on .The residents also complained about their babies been affected and some residents complained about the children with asthma had further attacks when the incident occurred. Most people living in the Wentworth, Austerville, Treasure Beach are now know about the automatic shutdown that occurred at the Engen Refinery yesterday morning as result of aniterruption to our high voltage electricity supply from municipality.many of those who were in the are would have seen the flares and smoke that resulted. What happened is that the shutdown caused fuel gas to be sent to the flares.



07 October 2010	On the 07/10/10 The communities complained about a very heavy Hydrogen Sulphide. Smell that was released by Engen refinery.
03 March 2011	At the ENGEN refinery a worker believed to be in his 30's was killed at 6.30 am working in a reactor on the polymerization plant.
10 October 2011	During morning hours the Engen refinery had a huge fire that scared the whole communities of the surrounding areas were gassed out and the settlers primary school kids about 100 of them had to be sent to hospital.

11 Nov 2004	27 November 2004 3 personal were injured at the Sapref refinery in South Durban when a fire occurred while they were de-spading a section of the hydrocarbon flare line in the central zone area. This was a planned activity to enable the hydro-desulphuriser unit to be commissioned after the scheduled maintenance shutdown. As is our standard requirement, a risk assessment was conducted prior to the start of the work .this identified the possibility of gas in the isolated section of the header and as a precaution breathing apparatus was an additional personal protective equipment requirement in the event of a gas release. The investigation this far suggests that liquid hydrocarbon was also present in the line and when the flange was loosened it ignited. 10 Dec 2004	High levels of catalyst are sent into the different separators and take a while to establish equilibrium for removal of the fines. This was visible as white smoke from the cat cracker stack.

02 FEB 2007	At 08h30 today, frantic residents of Wentworth and Merebank called the SDCEA offices concerned, after witnessing this huge plume of Diesel shooting into the atmosphere. They jammed the SDCEA telephone lines informing us of what is going on and urging us to rush to the scene. Mothers were worried about the children on the Fenceline of the Engen Refinery and the pipelines that run adjacent to the residential area. The pipeline that was gushing liquid into the atmosphere and spraying everyone was a Diesel line As per SAPREF's Communications Manager, Margaret Rowe's request for SDCEA & groundWork to formally address an urgent demand to Shell. It is unacceptable that Shell is replacing their pipelines while operating their old pipelines which are in the same vicinity. Considering the fact that this is a major hazardous installation,
